THE HONORABLE BOARD OF COMMISSIONERS:

WHEREAS, on March 18, 2020 the Iosco County Board of Commissioners closed the Iosco County Building/Courthouse and the Iosco County Annex Buildings to the general public and

WHEREAS, as a result of Governor Whitmer's Order to lift the "Stay Home Stay Safe" the Iosco County Building/Courthouse and the Iosco County Annex Buildings will re-open to the general public on Thursday, June 4, 2020 with the following guidelines:

- 1) Visitor screening and completion of COVID-19 questionnaire
- 2) Public will enter the building at the back door – security
- 3) Masks and social distancing encouraged
- 4) Public to exit the building at side door by Register of Deeds
- 5) Offices are responsible for their own sanitizing throughout the day with Sheriff Department trustees cleaning public areas, counters, door knobs, light switches etc. after hours. Janitorial Service will still be completing daily tasks after hours.
