IOSCO COUNTY GENERAL OPERATING TAX LEVY PROPOSAL

For the purpose of funding County general operations in Iosco County, shall the Constitutional limitation upon the total amount of taxes which maybe assessed in one (1) year upon all property within the County of Iosco, Michigan, be increased by up to 1.2871 mills (\$1.2871 per thousand dollars of state taxable valuation) for a period of six (6) years. (2023-2028) inclusive?

If approved and levied in full, this Millage will raise an estimated additional \$1,591,699.39 for general County operating purposes in the first calendar year of the levy based on state taxable valuation. If approved and levied, in accordance with State law, a small portion of the millage may also be disbursed to the Tax Increment Finance Authorities of Baldwin Township and the City of East Tawas, and the Oscoda-Wurtsmith Airport Local Development Finance Authority.

COUNTY VETERANS SERVICES PROGRAM PROPOSAL

For the sole purpose of funding Iosco County's obligation to provide financial relief and services for Iosco County veterans, including of eligible indigent veteran claims, and to fund the administration, services and financial aid to veterans of the Iosco County Department of Veterans Affairs, shall the constitutional limitation on general ad valorem taxes which may be assessed in any one (1) year upon all property within the County of Iosco as provided in Article 9, Section 6, of the Michigan Constitution be increased and the Iosco County Board of Commissioners be authorized to levy a tax up to an additional 0.1700 of one (1) mill (\$0.1700 per \$1,000 of taxable value) for the period of eight (8) years from 2022 through 2029, inclusive?

If approved and levied in full, this millage will raise an estimated \$209,760.00 in the first calendar year of the levy for the county veteran's program. As required by law, a small portion of the millage may also be disbursed to the Tax Increment Finance Authority of the Baldwin Township.
