IOSCO COUNTY PROPOSAL

IOSCO COUNTY GENERAL OPERATING TAX LEVY PROPOSAL

For the purpose of funding County general operations in losco County, shall the Constitutional limitation upon the total amount of taxes which maybe assessed in one (1) year upon all property within the County of losco, Michigan, be increased by up to 1.2871 mills (\$1.2871 per thousand dollars of state taxable valuation) for a period of six (6) years. (2023-2028) inclusive?

If approved and levied in full, this Millage will raise an estimated additional \$1,591,699.39 for general County operating purposes in the first calendar year of the levy based on state taxable valuation. If approved and levied, in accordance with State law, a small portion of the millage may also be disbursed to the Tax Increment Finance Authorities of Baldwin Township and the City of East Tawas, and the Oscoda-Wurtsmith Airport Local Development Finance Authority.

COUNTY VETERANS SERVICES PROGRAM PROPOSAL

For the sole purpose of funding losco County's obligation to provide financial relief and services for losco County veterans, including of eligible indigent veteran claims, and to fund the administration, services and financial aid to veterans of the losco County Department of Veterans Affairs, shall the constitutional limitation on general ad valorem taxes which may be assessed in any one (1) year upon all property within the County of losco as provided in Article 9, Section 6, of the Michigan Constitution be increased and the losco County Board of Commissioners be authorized to levy a tax up to an additional 0.1700 of one (1) mill (\$0.1700 per \$1,000 of taxable value) for the period of eight (8) years from 2022 through 2029, inclusive?

If approved and levied in full, this millage will raise an estimated \$209,760.00 in the first calendar year of the levy for the county veteran's program. As required by law, a small portion of the millage may also be disbursed to the Tax Increment Finance Authority of the Baldwin Township.

2022 BALLOT PROPOSAL

Shall the previous levy of .209 mill (\$.209 per \$1,000 of Taxable Value) be renewed for a period of 9 years from 2024 - 2032 inclusive, together with renewal of the previous levy of .291 mill (\$.291 per \$1,000 of Taxable Value) for a period of 8 years from 2025 - 2032 inclusive, for a combined levy of .500 mill (\$.500 per \$1,000 of Taxable Value) through the year 2032, such combined mills being for the continued purpose of operating and maintaining nutritional programs, home delivered meals, in home services and senior center supportive services for the County of losco older citizens as authorized by Act 39 of the Public Acts of 1976, and thereby continuing the same ad valorem tax rate of increase over the limitation imposed by Section 6 of Article IX of the Michigan Constitution of 1963?

This measure will result in an estimated revenue of \$616,943 for the first levy renewal year, being 2024.

PROPOSAL TO REPLACE IOSCO COUNTY EMERGENCY MEDICAL SERVICES MILLAGE

For the purpose of reauthorizing funding to support the operations of the Emergency Medical Services program currently being provided by losco County, shall losco County replace the current Emergency Medical Services millage of 0.60 mills due to expire in 2022, with an increase in the total amount of taxes which may be assessed in one (1) year under the Constitution upon all property within the County of losco, Michigan, at the new rate of up to 1.613 mills (\$1.613 per thousand dollars of state taxable valuation), for a period of four (4) years (2022-2025) inclusive?

If approved and levied in full, this millage will raise an estimated \$1,990,485 for emergency medical services in the first calendar year of the levy, based on state taxable valuation. If approved and levied, in accordance with State law, a small portion of the millage may also be disbursed to Tax Increment Finance Authorities of Baldwin Township and the City of East Tawas, and the Oscoda-Wurtsmith Airport Local Development Finance Authority.

IOSCO COUNTY ANIMAL CONTROL MILLAGE

For the sole purpose of providing funding for one (1) full-time and one (1) part-time Animal Control Officer and for operating losco County Animal Control Shelter, shall the Constitutional limitation upon the total amount of taxes which may be assessed in one (1) year upon all property within the County of losco, Michigan, be increased, and the County authorized to levy, up to 0.1500 of one (1) mill (\$0,15 per thousand dollars of state taxable valuation), for a period of four (4) years, 2022 through 2025, inclusive?

If approved and levied in full, this millage will raise an estimated \$184,935 for Animal Control Services in the first calendar year of the levy, based on state taxable valuation. If approved and levied, in accordance with State law, a small portion of the millage may also be disbursed to Tax Increment Finance Authorities of Baldwin Township and the City of East Tawas, and the Oscoda-Wurtsmith Airport Local Development Finance Authority.

CITY OF EAST TAWAS PROPOSAL

RENEWAL OF MOSQUITO CONTROL AND SUPPRESSION MILLAGE

Shall the City of East Tawas be authorized to renew an annual tax levy upon the taxable value against all property in the City of East Tawas, County of losco, State of Michigan for a period of five (5) years, 2023 through 2027, inclusive, for the sole purpose of providing mosquito control and suppression in the City of East Tawas? This renewal consists of a previously authorized millage of 0.4092 mill (as reduced by Headlee Amendment reductions), which expires following the 2022 tax levy. This renewal millage rate of 0.4092 mill will be subject to Headlee Amendment reductions, if any, in 2022 prior to the first year of the levy in 2023. The renewal millage of 0.4092 is projected to provide \$35,500 for the first year of the levy.

CITY OF WHITTEMORE PROPOSAL

FIRE PROTECTION MILLAGE

Shall the residents of the City of Whittemore levy an additional one-half (1/2) mill for the purpose of fire protection for a period of four (4) years, from and through 2022 - 2025, inclusive, which would result in \$0.50 per \$1,000 of taxable value raising in the first year an estimated \$13,197.78?

BALDWIN TOWNSHIP PROPOSAL

MILLAGE FOR ROAD CONSTRUCTION AND MAINTENANCE

Shall the expired previous voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution in Baldwin Township of 0.4892 mill (\$0.4892 per \$1,000 of taxable value), be renewed and increased at 1.0 mills (\$1.0 per \$1,000 of taxable value) and levied for 5 years, 2022 through 2026 inclusive, for Road Construction and Maintenance, raising an estimated \$126,263.00 in the first year the millage is levied.

BURLEIGH TOWNSHIP PROPOSAL

MILLAGE FOR FIRE PROTECTION

Shall the residents of Burleigh Township levy an additional one-half (1/2) mill for the purpose of fire protection for a period of four (4) years, from and through 2022 - 2025, inclusive, which would result in \$0.50 per \$1,000 of taxable value raising in the first year an estimated \$13,197.78?

PLAINFIELD TOWNSHIP PROPOSAL

FIRE MILLAGE RENEWAL

Shall the previous voted increase in the 15 mill tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution on general ad valorem taxes within Plainfield Township be levied at .50 mill (\$.50 per \$1,000 of taxable value) for the period of 2022 through 2025, inclusive, for Fire Department operation; and shall the Township levy such millage for said purpose, thereby raising in the first year an estimated \$121,822.37.

MEDICAL FIRST RESPONDER MILLAGE

Shall the previous voted increase in the 15 mill tax limitation imposed under Article IX, Sec 6 of the Michigan Constitution on general ad valorem taxes within Plainfield Township be levied at .15 mill (\$0.15 per \$1,000 of taxable value) for the period of 2022 through 2025, inclusive, for the operation, maintenance and training of a medical first responder unit within, and as a part of, the fire department; and shall the Township levy such a millage for said purpose, thereby raising in the first year an estimated \$36,546.00.

RENO TOWNSHIP PROPOSAL

MILLAGE FOR FIRE PROTECTION

Shall the residents of Reno Township levy an additional one-half (1/2) mill for the purpose of fire protection for a period of four (4) years, from and through 2022 – 2025, inclusive, which would result in \$0.50 per \$1,000 of taxable value raising in the first year an estimated \$16,322.00?

TAWAS TOWNSHIP PROPOSAL

PROPOSITION B

SHALL THE AD VALOREM TAX RATE IN THE TOWNSHIP OF TAWAS, IOSCO COUNTY, STATE OF MICHIGAN, BE INCREASED OVER THE LIMITATION IMPOSED BY SECTION 6 OF ARTICLE IX OF THE MICHIGAN CONSTITUTION OF 1963, BY THE PASSING OF A MILLAGE TO PROVIDE FOR ROAD IMPROVEMENTS, BY THE LEVY UPON SUCH PROPERTY, at the rate of one (1) mills (\$1.00 per \$1,000.00 of taxable value) for the next four (4) years, 2022–2025 with the amount of \$58,528.57 being collected in the first year the millage is levied. PROPOSITION A

SHALL THE AD VALOREM TAX RATE IN THE TOWNSHIP OF TAWAS, IOSCO COUNTY, STATE OF MICHIGAN, BE INCREASED OVER THE LIMITATION IMPOSED BY SECTION 6 OF ARTICLE IX OF THE MICHIGAN CONSTITUTION OF 1963, BY THE PASSING OF A MILLAGE TO PROVIDE FOR FIRE PROTECTION, BY THE LEVY UPON SUCH PROPERTY, at the rate of one and one-half (1-1/2) mills (\$1.50 per \$1,000.00 of taxable value) for the next four (4) years, 2022-2025 with the amount of \$87,792.86 being collected in the first year the millage is levied. This millage is a renewal of an existing millage for this purpose, unless renewed millage and service will otherwise expire at the end of this year.

HALE AREA SCHOOLS PROPOSAL

OPERATING MILLAGE PROPOSAL

This proposal will allow the school district to continue to levy the statutory rate of not to exceed 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its full revenue per pupil foundation allowance and restores millage lost as a result of the reduction required by the Michigan Constitution of 1963.

Shall the currently authorized millage rate limitation on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Hale Area Schools, losco and Ogemaw Counties, Michigan, be renewed by 17.9478 mills (\$17.9478 on each \$1,000 of taxable valuation) for a period of 10 years, 2024 to 2033, inclusive, and also be increased by .5 mill (\$0.50 on each \$1,000 of taxable valuation) for a period of 11 years, 2023 to 2033, inclusive, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and if .06 mill of the above is levied in 2023 is approximately \$10,523, and if 18 mills of the above are levied in 2024 is approximately \$3,701,052 (this millage is to renew millage that will expire with the 2023 levy and to restore millage lost as a result of the reduction required by the "Headlee" amendment to the Michigan Constitution of 1963 and will be levied only to the extent necessary to restore that reduction)?

IOSCO-ARENAC DISTRICT LIBRARY PROPOSAL

LIBRARY MILLAGE RENEWAL

Shall the losco-Arenac District Library, Counties of losco and Arenac, State of Michigan, be authorized to levy a millage annually in an amount not to exceed .4912 mill (\$.4912 on each \$1,000 of taxable value), which is a renewal of the previously authorized millage that expires in 2023, against all taxable property within the losco-Arenac District Library district for a period of ten (10) years, 2024 to 2033, inclusive, for the purpose of providing funds for all district library purposes authorized by law? The estimate of the revenue the losco-Arenac District Library will collect in the first year of levy (2024) if the millage is approved and levied by the District Library is approximately \$950,000.
